SIGNIFICANT REPRESENTATIVE MATTERS IN WHICH MR. TALLERICO HAS BEEN COUNSEL OF RECORD INCLUDE THE FOLLOWING:

- The arbitration of disputes relating to the non-renewal of automotive distributorships in Doha, Qatar and Beirut, Lebanon. The cases involved complex contract, choice of law, and damages issues, and were decided favorably by the AAA International Center For Dispute Resolution in New York in one instance and by the London Court of International Arbitration in the other.
- The successful arbitration and litigation, in London and throughout the United States, of disputes regarding the termination of other distribution relationships, including matters in Australia, Belgium, Luxembourg, Holland, Iraq, Germany, Greece, Lebanon, Spain, Portugal, Japan, Puerto Rico, the U.S. Virgin Islands, and throughout the United States.
- The defense of professionals, including most of the major accounting firms.
- Litigation between a U.S. oil company and its wholly owned subsidiary in Yemen to enjoin a Washington, D.C.based lawyer and his law firm from representing the Yemen Arab Republic (the "YAR") in all matters in which the oil company had an interest adverse to the YAR.

Auto-By-Tel, L.L.C.,* 966 F.Supp. 540 (E.D. Mich. 1997), is one example. In that action, an automobile dealership sought to restrain Mr. Tallerico's client, an Internet Web site operator, from terminating their contract.
